Western County wants to rehabilitate its road network and upgrade some from murram to bitumen standards. The county made a call for tenders. The tender document included the following information for bidders.

Award would be made following evaluation of bids as soon as funds were allocated by national government.

The procuring entity reserves the right to require a bid at any time in the evaluation procedure.

Award would be to the lowest bidder best suited to do the job in the best judgment of the evaluation committee.

Three bids submitted by Tractor construction, Smart construction and Techno construction were evaluated by the tender evaluation committee which recommended award of the tender to Tractor construction.

Western county had required a bid bond from Tractor construction before the award. Smart construction and Techno construction protested the award to Tractor construction arguing that the process was fundamentally flawed.
