QUESTION ONE

At the induction of the 2017 Kenya School of Law (KSL) class, two leading professors from the University of Kenya were invited. Professors PolePole of the School of Law and Malimingi of the School of Business. They were tasked to speak on the theme: Law is Business

Professor PolePole presented an illuminating and very persuasive paper. He argued that law is strictly a profession to be used in serving the cause of humanity. Making money was a minor and secondary concern. Supporting himself with legal authorities, he made a case to the effect that law is not and cannot be a commercial venture. Legal fees are only given as a token of appreciation.

QUESTION THREE

Lady Justice Majimazuri was hearing a case in which two advocates, Mulakazi and Malumbano are representing respective parties. Upon the conclusion of the trial, she scheduled a date for the delivery of the judgement. Two days prior to the scheduled judgement date, Malumbano Advocate wrote to Justice Majimazuri accusing her of being biased in light of questions she posed to both parties seeking clarification based on evidence adduced by both parties. In his communication, Malumbano Advocate categorically stated that he would be filing a motion before the Judicial Service Commission complaining on the conduct of Justice Majimazuri and petition for her removal as a judge.

Malumbano Advocate did not follow through on his threats and has once again appeared before Justice Majimazuri in another case and intends to proceed. The case has been rescheduled for hearing on another date before the same judge.

The judge has approached you for legal advice.
